

# TERMS OF SERVICE EFFECTIVE 21.07.2025

SANLAYAN TECHNOLOGIES PRIVATE LIMITED (referred to as "we" or "Sanlayan" or "Company"), a company existing under the Companies Act, 2013, is the author and publisher of the internet resource, website – https://www.sanlayan.com/ (the "Site"), and is a Company incorporated in 2023.

The vision is to become a strategic electronics company focused on developing indigenous technologies and to deliver cutting-edge electronics systems, meeting stringent technical specifications and quality standards.

Please carefully go through these User Terms (as defined hereinbelow) along with the **Privacy Policy** available on the Site before you decide to access the Site or avail of any Services. These User Terms and the Privacy Policy together constitute a legally binding agreement ("**Agreement**") between You and Sanlayan and shall apply to and govern your visit to and use, of the Site programming interfaces, software, tools, data, documentation, or website and any of its products or Services whether through a computer or a mobile phone as well as to all information, recommendations and or services provided to You on or through the Site.

### 1. **DEFINITIONS**

All of the defined and capitalized terms in these User Terms will have the meaning assigned to them here below:

- (i) "Applicable Laws" shall mean and include all applicable statutes, enactments, acts of legislature or parliament, laws, ordinances, rules, by-laws, regulations, notifications, guidelines, policies, directions, directives and orders of any governmental authority, tribunal, or a court of India including but not limited to the Indian Contract Act, 1872, the (Indian) Information Technology Act, 2000 (the "IT Act"), Digital Personal Data Protection Act, 2023 and the rules, regulations, guidelines and clarifications framed there under, including the (Indian) Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Information) Rules, 2011 (the "SPDI Rules"), and the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 (the "IG Rules").
- (ii) "User Terms" shall mean these terms of service.
- (iii) "Customer" or "Vendor" or "You" or "Your" or "Yourself" or "User(s)" shall mean any user of the Site or a visitor of the Site.
- (iv) "Force Majeure Event" shall mean any and all events arising due to any cause beyond the reasonable control of Sanlayan.
- (v) "Sanlayan" or "us" or "we" or "our" shall mean Sanlayan Technologies Private Limited, a company existing under the provisions of the Companies Act 2013, which expression shall, unless it is repugnant to the context or meaning thereof, be deemed to mean and include all its successors, affiliates and permitted assigns.
- (vi) "**Information**" shall mean all information on the Site, including but not limited to content, text, data, graphics, images, information, suggestions, and guidance.
- (vii) "Permitted Information" shall mean Registration Data or any other data submitted by you during the use of any Service offered through the Site.
- (viii) "Registration Data" shall mean and may include the present, valid, true, and accurate name, email ID, phone number, home and office addresses, bank account details, and any other information as may be required by Sanlayan from the User from time to time.

# 2. NATURE AND APPLICABILITY

This Agreement defines the terms under which you are allowed to use the Site while you are registered as a User with us. These User Terms apply to the services made available by Sanlayan on the Site and to other users/visitors of the Site.



- (a) By accessing the Site to use the Services, you irrevocably accept all the User Terms stipulated in this Agreement and agree to fully abide by them.
- (b) This Agreement supersedes all previous oral and written terms and conditions (if any) communicated to you. By availing of any Service, you signify your acceptance of this Agreement. We reserve the right to modify or terminate any portion of the Agreement for any reason and at any time.
- (c) Your acceptance of the User Terms shall also be deemed to include your acceptance of the Privacy Policy available at the Site.
- (d) You should read these User Terms at regular intervals. Your use of the Site following any such modification constitutes your agreement to follow and be bound by these User Terms so modified. This electronic record is generated by a computer system and does not require any physical or digital signatures.

## 3. MINIMUM AGE

You must be 18 years of age or older to register, use the Services, or visit or use the Site in any manner. Sanlayan will not be responsible for failure or delay of performance for any Services if caused by: an act of war, hostility, or sabotage; act of God; electrical, internet, or telecommunication outage that is not caused by the obligated party; government restrictions; pandemic; or other event outside the reasonable control of the obligated party.

  - (ii) A third party reports the violation of any of its rights as a result of your use of the Services:
  - (iii) Sanlayan is unable to verify or authenticate any information provided to Sanlayan by a User;
  - (iv) Sanlayan has reasonable grounds for suspecting any illegal, fraudulent, or abusive activity on the part of such User; or;
  - (v) Sanlayan believes in its sole discretion that the User's actions may cause legal liability for such User, other Users, or Sanlayan, or are contrary to the interests of the Site.
- (c) Termination of this Agreement will not prejudice accrued rights of either Sanlayan or the User.

No delay in exercising any right or remedy or failure to object will be a waiver of such right or remedy or any other right or remedy.
